Superintendent Bradley advised that funding of the Cherry Blossom Festival is provided by a resident of Sausalito who has a keen interest in increasing awareness of Japanese culture. Japanese instructors in NOH drumming come to the Bayside/Willow Creek Academy campus 4 times each year to work with students. Trustee Benjamin suggested the Board recognize her at a future Board meeting.

BUDGET BUDGET

Clark Warden reviewed Willow Creek Academy financial statements for the period ending March 31, 2009. The preliminary budget is almost complete and ready to go to the WCA Board. The projected net deficit is \$14,000 to \$17,000 (an accrual number). WCA Financial Report

Margie Bonardi spoke of the Federal stimulus money for Special Education, Title 1, and SFSF stimulus money - all backfill for school districts who have lost money through revenue limit and for lost categorical funding. The District and Willow Creek Academy will both apply for funds. The vote in May does not impact this.

The Board considered a proposal from Buck Consultants to provide a required Gatsby 45 audit of retiree postemployment benefits. Margie Bonardi explained that districts must make a commitment to pay health care costs for retirees and fund for the liability.

William Gargan discussed the future changes for the stage production lighting which would be costly and will push the schedule out two more weeks. This extended schedule will cause \$17,000 in delays and the pre-wiring will total around \$75,000. He recommends not proceeding with the theater lighting plan but to bring it to the Facilities Subcommittee. Secondly, the PG&E under grounding may cause a schedule delay since the power needs to be in building to paint and finish the building before school starts.
